## Boeing Names Rinaldo Petrignani To Lead Boeing-Italy

The Boeing Company today named Rinaldo Petrignani vice president of Boeing International Relations for Italy. Petrignani will be responsible for coordinating all company business activities in Italy and will be based in Rome at the Boeing-Italy headquarters.

"Boeing has enjoyed a long term in-depth relationship with Italian industry," said Phil Condit, Boeing chairman and chief executive officer. "Italy is a vibrant, growing economy and home to an increasing number of important customers and partners. Rinaldo will help us to further develop these relationships."
