### **Boeing and MBDA Announce Missile Defense Partnership**

Boeing [NYSE:BA] and European weapons manufacturer MBDA have signed a memorandum of understanding to develop a cooperative relationship in the area of global missile defense.

Under this agreement, the two companies will evaluate and develop opportunities in missile defense drawing on their existing skills, technologies and capabilities. Collaboration will include potential short-term and long-term business relationships and examination of architectures for defending against global and regional ballistic missile threats.

Boeing is the prime contractor of the U.S. government's Ground-based Midcourse Defense and Airborne Laser programs. The company has established missile defense agreements in the United Kingdom, Canada, Poland, Russia, Ukraine, Turkey, France, Italy, the Netherlands, Israel and Japan.

"Our relationship with MBDA is a critical component of our growing global missile defense partnerships," said James Evatt, Boeing Senior Vice President of Missile Defense Systems. "This agreement represents another step forward in expanding global cooperation in the missile defense arena and identifying solutions that are critical for the future security of our nations, military forces and allies."

Marwan Lahoud, Chief Executive Officer of MBDA said, "We are proud to link with Boeing which already has prime involvement in some of the U.S. government's major missile defense programs."
