Boeing [NYSE: BA] has announced a supplier agreement with Olympic Tool & Machine, Corp., to support the proposed HH-47 Combat Search and Rescue helicopter program for the U.S. Air Force.

CSAR-X is a U.S. Air Force initiative to procure more capable and survivable aircraft able to recover isolated personnel from hostile or denied territory. The tandem rotor, heavy lift, high altitude HH-47 is based on the CH/MH-47 Chinook transport helicopter, with performance capabilities that have been widely demonstrated in the ongoing war on terrorism and in numerous U.S. and international humanitarian relief operations.

"Besides bringing new work to our local area and stabilizing our workforce, it is a special privilege to be involved in the Air Force program that will ultimately provide life-saving technology to our troops and civilians around the world."
