AMMROC and Boeing Defense, Space & Security announce strategic agreement to support UAE military aviation platforms

DUBAI, United Arab Emirates, Nov. 14, 2011 -- Boeing [NYSE: BA] and Mubadala Aerospace, a business unit of the Abu Dhabi-based Mubadala Development Company, a business development and investment vehicle of the Abu Dhabi government, today announced agreements to advance the commercial and military aviation industry in the United Arab Emirates (UAE).
